2. **SUMÁRIO EXECUTIVO**

2.1. A presente Nota Técnica tem por finalidade responder ao Requerimento de Informação nº 1.205, de 2024 (SEI 4864658), de autoria da Comissão de Educação da Câmara dos Deputados, que solicita informações acerca do "andamento do acordo firmado com o Banco Mundial para investimento no Novo Ensino Médio".

3. PROJETO DE APOIO À IMPLEMENTAÇÃO DO NOVO ENSINO MÉDIO

- 3.1. A Coordenação-Geral de Ensino Médio (COGEM/DPDI/SEB/MEC) informa que, no âmbito da Política Nacional para a etapa do ensino médio nas escolas públicas, o Ministério da Educação (MEC) fomenta Programas e ações em apoio à implementação do Ensino Médio, atendendo ao preconizado pela Lei nº 9.394, de 20 de dezembro de 1996 (LDB), pela Lei nº 13.415, de 16 de fevereiro de 2017, e, também, pela Lei nº 13.005, de 25 de junho de 2014 (PNE).
- 3.2. A Reforma do Ensino Médio, estabelecida pela Lei nº 13.415/2017, conta também com o apoio do Banco Internacional para Reconstrução e Desenvolvimento BIRD, por meio do Acordo de Empréstimo nº 8812-BR e 8813-BR, firmado em 24 de maio de 2018, entre a República Federativa do Brasil e BIRD, no valor de U\$ 250 milhões, por meio do Projeto de Apoio à Implementação do Novo Ensino Médio, que estão distribuídos em dois componentes:
 - a) Componente 1 nº 8812-BR: PforR no Valor de US\$ 221 milhões Composto por Programas Orçamentários e Ações do Plano Plurianual (PPA) previamente selecionados e acordados, vinculados a uma parte do orçamento do MEC à resultados educacionais, o que induz a continuidade do Programa nas transições de gestão, e por Indicadores Vinculados a Desembolsos relacionados com os objetivos do Programa que condicionam os desembolsos em função do cumprimento de metas.
 - b) Componente 2 nº 8813-BR no valor de U\$\$ 29 milhões Consiste em apoiar a implementação da Reforma do Ensino Médio, por meio de um conjunto de assistências técnicas, fortalecendo a capacidade institucional do MEC e SEE's para assegurar a correta implementação da Reforma do Ensino Médio.
- 3.3. Os Objetivos de Desenvolvimento do Projeto (ODP) são: (I) fortalecer a capacidade das secretarias estaduais de educação de implementar a reforma do ensino médio, priorizando as escolas vulneráveis; (II) apoiar a expansão do Programa de Escolas de Tempo Integral no território brasileiro e (III) apoiar a resposta à pandemia de COVID-19 no setor da educação.

4. REQUERIMENTO DE INFORMAÇÃO № 1.205, DE 2024, DA COMISSÃO DE EDUCAÇÃO DA CÂMARA DOS DEPUTADOS.

- 4.1. Em atenção ao Despacho nº 2110/2024/CHEFIA/GAB/SEB/SEB-MEC (SEI 4866795), que encaminhou o Ofício nº 1677/2024/ASPAR/GM/GM-MEC (SEI 4864667), da ASPAR, que envia o Requerimento de Informação nº 1.205, de 2024 (SEI 4864658), de autoria da Comissão de Educação da Câmara dos Deputados, que solicita informações acerca do "andamento do acordo firmado com o Banco Mundial para investimento no Novo Ensino Médio".
- 4.2. Visando cumprir o que determina a Constituição Federal e a <u>Portaria MEC nº 255, de 27 de março de</u> 2024, esta Coordenação-Geral de Ensino Médio apresenta a manifestação quanto aos itens do Requerimento de

competência da Secretaria de Educação Básica.

- 4.3. Cada pergunta do Requerimento de Informação está respondida de <u>forma individual e organizada item</u> <u>a item.</u>
 - 1- Considerando que o contrato foi celebrado em 2018, quais foram as metas firmadas no acordo com o Banco Mundial e quais delas já foram alcançadas? Solicito que sejam fornecidas informações detalhadas sobre todas as metas já alcançadas e o panorama de resultado de todas as metas a serem cumpridas.
- 4.4. No âmbito do Componente 1 do Projeto, os fundos são desembolsados em Dólares dos Estados Unidos em conta designada pelo Mutuário, sob gestão da Secretaria do Tesouro Nacional, com base nos Indicadores Vinculados a Desembolso (IVD) alcançados. O valor total do componente 1 é desembolsado em função dos IVDs atingidos e comprovados pelo MEC.

- 2- A atual gestão do Ministério da Educação, no Governo de transição, recebeu um plano de ação para o cumprimento das metas restantes? Caso positivo, solicitamos o envio deste documento.
- 4.5. Com relação a atual gestão, nos dias 27 a 29 de março e 03 a 04 de abril de 2023 foi realizada no Ministério da Educação a missão de supervisão do Projeto, com representantes da nova gestão e integrantes do BIRD. A agenda teve como objetivos: (I) apoiar a implementação das atividades e ações dos componentes e resultados do projeto; (II) acompanhar e apoiar os processos de aquisições; (III) acompanhar e apoiar a gestão financeira do projeto; (IV) acompanhar o desenvolvimento dos planos de gestão social e ambiental e (V) discutir a proposta de reestruturação do projeto. Na ocasião, a Unidade de Gestão de Projetos (UGP) apresentou o status financeiro, de aquisições, social e ambiental, bem como o planejamento para o cumprimento e desembolso dos IVDs faltantes. Foram, ainda, apresentados os desafios e gargalos para a execução do Projeto. Durante a missão, discutiu-se algumas propostas iniciais da reestruturação e a prorrogação do Acordo de Empréstimo, tendo como justificativa a Consulta Pública para a avaliação e reestruturação da política nacional do Ensino Médio (Portaria MEC 399/2023), com a finalidade de coletar subsídios para a tomada de decisão do MEC acerca dos atos normativos que regulamentam o Novo Ensino Médio. Nesse contexto, o MEC tem empreendido esforços em prol da superação de alguns gargalos na execução de algumas ações previstas no Acordo de Empréstimo nº 8812/BR e 8813/BR.
 - 3- A atual gestão do Ministério da Educação formulou, adequou ou alterou o plano de ação para o cumprimento das metas restantes? Caso positivo, favor enviar o novo plano e/ou as alterações realizadas.
- 4.6. Em novembro de 2023, foi encaminhado à Secretaria de Assuntos Internacionais e Desenvolvimento SEAID a segunda solicitação de alterações no Acordo de Empréstimo nº 8812-BR e nº 8813-BR. O pleito teve o propósito de permitir as alterações nos arranjos de implementação da operação e na tabela de desembolso do Projeto, com a finalidade de adaptar a matriz de resultados e as atividades de suporte à implementação no contexto do processo de consulta pública e avaliação e reestruturação da Política Nacional de Ensino Médio e prorrogar por mais um ano o Projeto, permanecendo as alocações dos recursos financeiros para o Componente 1 inalterada, e com alterações as alocações dos recursos financeiros para o Componente 2.
- 4.7. A reestruturação do Projeto de Suporte à Reforma do Ensino Médio foi justificada pela necessidade de estender o Projeto, adaptar a matriz de resultados e as atividades de suporte à implementação no contexto do

processo de consulta pública e avaliação e reestruturação da política nacional de ensino médio, conforme Portaria MEC nº 399/2023.

4.8. As alterações realizadas estão listadas abaixo:

Proposta de IVDs a serem retirados (Valor total: US\$27,5 milhões)

- a) DLR 4 do IVD 8 (IRI 16.1, US\$ 15,0 milhões). O IVD 8 é relativo às avaliações e ajustes do programa de EMTI. O IVD 8 foi parcialmente alcançado em 2019 (DLR 1) quando a pré-avaliação foi concluída satisfatoriamente. Uma vez que a realização do DLR 4 (uma análise rigorosa dos processos, produtos e resultados do programa EMTI é realizada e as melhores práticas para apoiar sua implementação são disseminadas) depende da implementação do Componente 2, este IVD será descartado, mas permanecerá como IRI observando a complexidade relacionada à sua implementação.
- b) DLR 5 do IVD 12 (IRI 3.3, US\$ 12,5 milhões). O IVD 12 é o Novo Modelo de Avaliação do ENEM alinhado à Reforma do Ensino Médio aprovado e implantado. O DLR 4 foi alcançado quando o grupo de trabalho para a elaboração das matrizes de avaliação do novo ENEM foi criado e seus trabalhos publicados em 2022. O DLR 5 (São publicadas as matrizes de avaliação do novo ENEM) não está previsto para ser concluído antes de 2024, portanto este DLR será descartado.

Proposta de IVDs a serem revisados (Valor total: US\$12.9475 milhões)

- c) **DLR 4 e 5 do IVD 13 (IRI 1.16, US\$ 27,9475 milhões).** O IVD 13 (*Medidas implementadas pelo MEC para responder à crise da COVID*) **foi parcialmente alcançado em 2022.**
- d) O DLR 4 foi parcialmente alcançado em 2022 (US\$ 10 milhões desembolsados), quando o MEC entregou (I) protocolos de saúde para a reabertura segura das escolas, (II) painel para monitorar o contexto e o andamento de cada estado. No entanto, (III) a disseminação de estratégias para a recuperação da aprendizagem perdida para trazer os alunos de volta à escola prevista no DLR4 ainda não foi alcançada (US\$ 5 milhões não desembolsados). A reestruturação mudará a meta final do DLR 4 para 2024.
- e) O DLR 5 também foi parcialmente alcançado (US\$ 5 milhões desembolsados) quando o MEC forneceu aos Estados (I) apoio técnico e financeiro para melhorar a conectividade escolar. A segunda meta (II) do DLR 5 (equipamentos necessários para oferecer educação a distância e híbrida centros de mídia e kits escolares, US\$ 7,9475 milhões não desembolsados) será atrelada ao avanço da conectividade escolar e deste modo será criado um novo IVD. A reestruturação deletará o DLR e os recursos serão alocados em um novo IVD.

Proposta de IVDs a serem adicionados (Valor total: US\$35.447.500,00)

- f) IVD 14 (US\$ 7.5 milhões): divulgação dos resultados da Pesquisa Novo Ensino Médio, realizada com alunos, professores e gestores escolares sobre a experiência de implementação da reforma do Ensino Médio no país. Este novo DLI monitora a percepção e avalia os desafios enfrentados pelas escolas públicas sobre a implementação da reforma. Esta pesquisa contribuirá para o aprimoramento da gestão da política nacional de ensino médio.
- g) IVD 15 (US\$ 10 milhões): legislação do MEC que institucionaliza a reestruturação da política nacional de ensino médio. O MEC altera os normativos e redefine orientações curriculares com base na reestruturação da política. Este novo DLI monitorará os novos normativos sobre: I) carga horária; II) organização curricular parte flexível; III) educação profissional e tecnológica (EPT) e IV) educação a distância. Fornece apoio técnico aos estados para o processo de elaboração dos planos de ação em consonância com a reestruturação da política.
- h) IVD 16 (US\$ 17.9475 milhões): fortalecimento da conectividade nas unidades escolares através do fornecimento de equipamentos necessários que viabilizem uma educação híbrida para promover estratégias de recuperação de aprendizagem núcleos de inovação e kits escolares; I) 20 estados com centros de mídia instalados com equipamentos necessários para ofertar ensino híbrido (US\$ 7.9475 milhões) II) 1.487 escolas vulneráveis (INSE I, II e III) com kits escolares fornecidos necessários para ofertar ensino híbrido (US\$ 10 milhões).
- 4 De acordo com o plano de ação, qual a expectativa de cumprimento das metas e recebimento dos repasses nos próximos 3 (três) anos?
- 4.9. A reestruturação realizada em dezembro de 2023 prorrogou o prazo de encerramento do Projeto por 1 (um) ano, com encerramento para o dia 31 de dezembro de 2024.
- 4.10. O cumprimento dos IVDs e previsão dos desembolsos faltantes estão explicitados no quadro abaixo.

- 4.11. Como citado acima, em novembro de 2023 foi encaminhado à Secretaria de Assuntos Internacionais e Desenvolvimento SEAID, a segunda solicitação de alterações no Acordo de Empréstimo nº 8812-BR e nº 8813-BR. O pleito teve o propósito de permitir as alterações nos arranjos de implementação da operação e na tabela de desembolso do projeto, com a finalidade de adaptar a matriz de resultados e as atividades de suporte à implementação no contexto do processo de Consulta Pública e avaliação e reestruturação da política nacional de ensino médio e prorrogar por mais um ano o projeto, permanecendo as alocações dos recursos financeiros para o Componente 1 inalterada, e com alterações as alocações dos recursos financeiros para o Componente 2.
- 4.12. A reestruturação do Projeto de Suporte à Reforma do Ensino Médio foi justificada pela necessidade de estender o Projeto, adaptar a matriz de resultados e as atividades de suporte à implementação no contexto do processo de Consulta Pública e avaliação e Reestruturação da Política Nacional de Ensino Médio, conforme Portaria MEC nº 399/2023.
- 4.13. Na solicitação citada o prazo de encerramento do Projeto foi prorrogado por 1 (ano) ano, até 31 de dezembro 2024, considerando: (I) nova gestão de governo/MEC; (II) suspensão do cronograma de implementação da reforma, conforme Portaria 627/2023; (III) a conclusão e os apontamentos da consulta pública para a avaliação e reestruturação da política nacional de Ensino Médio; (IV) a realização das principais atividades relacionadas à implementação da Reforma e (V) a reorganização das estratégias para atender e apoiar o atual cenário da política nacional do ensino médio.
- 4.14. Em anexo, encaminhamos o documento do segundo termo aditivo do Acordo de Empréstimo nº 8812-BR (Programa) e nº 8813-BR (Projeto) (SEI 4879312), firmado entre a República Federativa do Brasil e o Banco Internacional para Reconstrução e Desenvolvimento (BIRD), para conhecimento.

Excellency,

We refer to the Loan Agreement (the "Loan Agreement") entered between the Federative Republic of Brazil (the "Borrower") and the International Bank for Reconstruction and Development (the "Bank"), dated May 24, 2018, and amended and restated on March 15, 2022, for the above-captioned Project (the "Project"). Please note that capitalized terms used in this letter (the "Amendment Letter") not defined herein have the meaning ascribed to them in the Loan Agreement.

We also refer to: (i) the Technical Group of the Committee for External Financings' (GTEC/COFIEX) Recommendation No. 43, dated December 6, 2023; (ii) PGFN's approval through *Parecer* SEI N° 5227/2023/MF, dated December 20, 2023; and (iii) letter *Oficio* No 5682/2023/ ASTEC/GM/GM-MEC, dated November 14, 2023, requesting, *inter alia*: (i) an extension of the closing date for 12 (twelve) months; (ii) changes to Component 2 of the Project; (iii) changes in the disbursement table; and (iv) a partial cancellation of the amount allocated under the Project (Category 11 of the Disbursement Table), in the amount of nineteen million three hundred fourteen thousand two hundred seventy-three Dollars (US\$ 19,314,273).

We are pleased to inform you that the Bank agrees to the proposed changes and to amend the Loan Agreement as follows:

1. Article 3.01 of the Legal Agreement is hereby amended to read in its entirety as follows:

The Borrower declares its commitment to the objectives of the Operation. To this end, the Borrower shall carry out the Operation through MEC, with the assistance of the FNDE, the SEEs, and the Public Schools for activities under the Operation that falls under their administrative jurisdiction, as follows: (i) FNDE, within its legal mandate, to carry out selected activities under Parts 1 and 2 of the Operation; (ii) SEEs to carry out selected activities under Parts 1 and 2 of the Operation; (iii) Public Schools to carry out selected activities under Parts 1 and 2 of the Operation; all in accordance with the provisions of Article V of the respective General Conditions, and the Relevant Commitment Agreements.

- 2. Part 1(c)(ii) of Schedule 1 to the Legal Agreement is hereby amended to read in its entirety as follows:
 - "(ii) strengthen virtual education delivery and implement a hybrid education model in Upper Secondary Education, applied to the new curriculum and the FTS, including improved connectivity and the availability of media centers."
- 3. Part 2(b) of Schedule 1 to the Legal Agreement is hereby amended to read in its entirety as follows:
 - "b) Support the short and long-term response to the COVID-19 pandemic through, inter alia: (i) supporting the design of a hybrid model that combines virtual and in-person learning; (ii) supporting digital connectivity in schools; (iii) supporting the purchase of equipment to facilitate hybrid education at the State level; and (iv) developing studies to ease the return to school and determine remedial actions post-COVID-19."
- 4. Section IV.A.1(a) of Schedule 2 to the Legal Agreement is hereby amended to read in its entirety as follows:
 - "(a) with respect to the Program: (i) finance the results ("Disbursement Linked Results" or "DLRs") achieved by the Borrower, as measured against specific indicators ("Disbursement Linked Indicators" or "DLIs") in the amounts allocated against Categories (1) through (10) and (14) through (19); (ii) pay the Front-end Fee; and (iii) pay the Interest Rate Cap or Interest Rate Collar premium, all as set forth in the table in paragraph 2 of this Part A; and (…)"
- 5. The chart in Section IV.A.2 of Schedule 2 to the Legal Agreement is hereby amended to read in its entirety as follows:

"D. Operation Withdrawal Period

"The Closing Date is December 31, 2024. The Bank may grant an extension of the Closing Date only after the Borrower's Ministry of Finance has informed the Bank that it agrees with such extension."

- 7. The Appendix to the Loan Agreement is amended by <u>replacing</u> the following definitions in its entirety as follows:
 - "22. "Learning Itineraries Program" means Programa Itinerarios Formativos, the Borrower's program created by the Learning Itineraries Portaria."
 - "31. NEM Legal Framework" means the Borrower's Law No. 13.415, dated February 16, 2017, or any successor or successors to such legislation which shall be acceptable to the Bank for purposes of the Operation."

8. The Appendix to the Loan Agreement is amended by <u>excluding</u> the following definition in its entirety:

"15. Full-Time Upper Secondary School Expansion Support Program means the Programa de Fomento às Escolas de Ensino Médio em Tempo Integral (EMTI), as established by MEC regulation No. 1.144 dated October 10, 2016."

9. The Appendix to the Loan Agreement is amended by <u>adding</u> the following definitions placed in alphabetical order and renumbering existing definitions accordingly:

"Full-Time School Program" means the Programa Escola em Tempo Integral (PETI), as established by Law No 14,640, dated July 31, 2023, or any successor or successors to such legislation which shall be acceptable to the Bank for purposes of the Operation."

"Restructuring of the Upper Secondary Education Legal Framework" means any amendments to the NEM Legal Framework, in form and substance acceptable to the Bank, or any successor or successors to such legislation which shall be acceptable to the Bank for purposes of the Operation."

All other provisions of the Loan Agreement, except as amended through this Amendment Letter, shall remain in full force and effect.

This Amendment Letter shall be executed in three (3) counterparts, each of which shall be an original. Upon your confirmation, please return one fully executed original to us. The provisions set forth in this Amendment Letter shall become effective as of January 1st, 2023, upon the Bank's receipt of one (1) fully executed original of this Amendment Letter.

I. PROGRAM STATUS AND RATIONALE FOR RESTRUCTURING

1. This Restructuring Paper seeks approval of the Country Director for a Level II restructuring of the Support to Upper Secondary Reform in Brazil Operation. This would be the second restructuring of this Operation. The proposed restructuring is needed to update the results framework and the Disbursement Linked Indicators (DLIs), as well as to strengthen existing activities and to add new ones. The proposed changes will allow to enhance implementation of the Upper Secondary Education Reform, in line with a national public consultation that delayed and reoriented the implementation of the Reform.¹ In addition, the proposed restructuring would extend the Operation's closing date by 12 months, from December 31, 2023 to December 31, 2024, to allow time to carry out all planned activities, and partially cancel Loan proceeds under IBRD 8813 (Component 2). Changes in disbursements arrangements and estimates, safeguard policies, institutional arrangements and implementation schedule are also needed to adapt the Operation to the new design of the Upper Secondary Education Reform.

Overall Status of Implementation

- 2. The Operation was approved by the World Bank's Board of Executive Directors on December 14, 2017, and became effective on July 23, 2018. The Operation was restructured on February 3, 2022 to (i) revise the PDO; (ii) revise the activities under Component 1; (iii) update activities under Component 2; (iii) revise the Results Framework, including DLIs; (iv) update disbursement estimates; and (v) align the theory of change to the revised PDO.
- 3. Progress towards achievement of the Development Objective was rated Moderately Satisfactory in the latest Implementation Status and Results Report (ISR), dated June 11, 2023. Significant progress has been made toward achieving the PDO indicators, since the February 2022 restructuring, as follows:
 - i. PDO Indicator (PDOI) 1 Number of States where at least 40% of schools have implemented the New Curricula in the 1st grade of Upper Secondary Schools Education. PDOI 1 has reached 25 out of the 27 target states and is on track to achieve its final target, which can only be measured in 2024 because of the availability of the 2023 School Census data. The remaining 2 states are in the process of approving the New Curricula in the state education councils.
 - ii. PDOI 2 Number of States where at least 60% of vulnerable schools have implemented the New Curriculum in the 1st grade of Upper Secondary Schools: This indicator reached 24 states in 2023, exceeding the end target of 22.
 - iii. PDOI 3 was dropped in the previous restructuring.
 - iv. PDOI 4 Number of enrolled students in upper-secondary schools participating in the Full-Time School (FTS) program: This indicator has been achieved, reaching 361,329 students compared to the end target of 350,000.
 - v. PDOI 5 Implementation of a safe and effective reopening of upper-secondary schools: This indicator will not be achieved by the current closing date. Key measures to support the safe reopening of New Upper Secondary Education (*Novo Ensino Médio*, NEM) schools were implemented, but the Operation will only be able to offer distance education as part of a hybrid model in at least 15 States if the operations closing date is extended by 12 months.
- 4. There was also progress on the verification of eligible expenditures that increased from 39 percent to 62 percent of the total allocated to Component 1, but the verification of all remaining eligible expenditures is unlikely to be completed by the current closing date of the Operation. Most of the delay in the verification of eligible expenditures was caused by

¹ The public consultation was held after the Ministry of Education (*Ministério da Educação*, MEC) issued a legal ordinance (*Portaria*) that suspended the timeline for implementation of the Reform (No. 627, April 4, 2023) due to national pressure from unions, universities, and student associations to restructure or even cancel the Reform.



the limited capacity of the Project Management Unit (PMU) at the beginning of implementation and the lack of collaboration with the financial unit of the Ministry of Education (Ministério da Educação, MEC) and the National Fund for the Development of Education (Fundo Nacional para o Desenvolvimento da Educação, FNDE). Since the last ISR, US\$138 million have been verified and US\$83 million are under analysis. The Operation's current eligible expenditure program remains adequate as it is expected to generate sufficient eligible expenditures by 2024.

5. The Operation has disbursed US\$183.63 million to date (73.45 percent of the total loan amount). A total of US\$40.5 million, corresponding to four Disbursement-Linked Results (DLR) under Component 1 will not be disbursed by the current closing date of December 31, 2023, as they correspond to activities that were affected by the suspension of the implementation schedule of the reform. Their achievement also depends on the consolidation of the institutional arrangement with FNDE and Sub-Secretary of Administrative Management (Subsecretaria de Gestão Administrativa, SGA) regarding the roles and responsibilities for procurement processes, as well as on the availability of the discretionary budget for SEB. In addition, most Component 2 activities can no longer be finalized by the current closing date due to the same severe impacts of the pandemic on the education sector, the suspension of the implementation schedule of the reform, and the non-consolidation of the institutional arrangement.

Component 1. Supporting the New Upper Secondary Education (Program for Results)

Results Area 1. Support the Implementation of the New Curriculum

- 6. MEC has played a significant role in supporting the implementation of NEM, including the technical and operational support to the states to carry out the NEM at the school level. Since the enactment of Law 13415, 2017, and the publication of the National Common Core Curriculum (Base Nacional Comum Curricular, BNCC) in 2018, MEC support is evident through several measures, including: (i) the issuance of a regulatory decree (Portaria) to govern the NEM and establish national guidelines for its implementation; (ii) the enhancement of the capacity of State Secretariats of Education (Secretarias Estaduais e Distrital de Educação, SEEs) in planning, implementing, and monitoring the educational reform; (iii) the adaptation of the existing National Textbook Program (Programa Nacional do Livro Didático, PNLD) to align with the NEM framework, encompassing digital books; and (iv) the overhaul of assessments for upper secondary education and entry into higher education. This overhaul includes the Upper Secondary Education National Exam (Exame Nacional do Ensino Médio, ENEM) and the diagnostic National Assessment of Basic Education (Sistema de Avaliação da Educação Básica, SAEB). At the state level, key activities have encompassed: (i) the development of new state curricula, featuring formative itineraries aligned with the NEM; (ii) the training of school principals, pedagogical coordinators, and teachers to effectively implement the NEM; and (iii) the reorganization of school networks to meet the demands of the NEM. Despite these efforts, notable delays in the accountability of state expenditures (prestação de contas) by the National Fund for Educational Development (Fundo Nacional de Desenvolvimento da Educação, FNDE) have been observed and are attributed to the limited capacity to conduct additional accounting activities, posed by the additional responsibilities of the Operation.
- The status of Intermediate Results Indicators (IRI) and Disbursement Linked Indicators (DLIs) for Results Area 1 is 7. as follows:
 - i. IRI 1.1 (DLI 1) "The MEC NEM Portaria regulating the support to the Upper Secondary Education Reform has been published:" the end target was achieved in 2018.
 - ii. IRI 1.2 "Analytical Reference Tools for the implementation of NEM are developed and disseminated to SEE:" the end target was achieved in 2020, with relevant guidelines and directives developed and distributed to all SEEs.
 - iii. IRI 1.3 (DLI 2) "Number of States that formally signed the NEM Portaria Commitment Agreement:" the end target was achieved in 2020, with all 27 states having signed the Commitment Agreement.
 - IRI 1.5 (DLI 4) "Number of States that have their curricula adapted to NEM, validated and published by each iν.



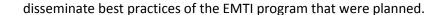

- State:" all 27 states had their curricula adapted and adopted by the State Council of Education, achieving the end target.
- v. IRI 1.8 (DLI 6) "Number of States with schools in NEM Implementation Pilots:" the end target was achieved, with 20 states carrying out the NEM implementation pilots in 2021.
- vi. IRI 1.10 "Number of States that included an itinerary of technical and/or professional education in their NEM curricular proposal:" all 27 states have included these itineraries.
- vii. IRI 1.12 "Number of States that have trained key SEE staff in the new state curriculum:" the end target of 25 states has been achieved.
- viii. IRI 1.14 (DLI 11) "Number of States that have received the books and didactic materials aligned with NEM": the development of digital didactic materials has been completed (BNCC and *Projeto de Vida*) and distribution to states was completed in 2022:" object 1 (27 states) and object 2 have been fully achieved.
- ix. IRI 1.15 (DLI 12) "Publication of assessment matrixes of new ENEM in accordance with the NEM Legal Framework:" the working group was created, but it is currently unclear if DLR 5 "Assessment matrixes of new ENEM are published" can be achieved by the current closing date given the suspension of the implementation schedule of the reform.
- x. IRI 1.16 (DLI 13) "MEC implements measures to respond to COVID crisis:" the target for 2022 has been achieved, specifically: (a) establishing and disseminating health protocols for schools that guide and protect teachers and students; and (b) developing a Web portal to monitor and publicly share the status and evolution of states and schools in relation to the pandemic. DLR 5 "Provide States with (i) technical and financial support to improve school connectivity, and (ii) equipment needed to offer distance and hybrid education (media centers and school kits" will only be reached by December 2024, as these activities depend on the consolidation of the institutional arrangement with FNDE and SGA.

Results Area 2. Promoting the Expansion of Full-Time Schools

- 8. The Full-time Upper Secondary School Expansion Support Program (Programa de Fomento às Escolas de Ensino Médio em Tempo Integral, EMTI) has been under implementation since 2016 and was originally established for a period of 10 years. In 2022, it covered a total of 1,412 schools in all 26 states and the Federal District and benefited more than 360,000 students. To date, MEC has published four *Portarias*, each establishing the number of schools and students under the scope of the EMTI program for that edition: Portaria 1145 of 2016 for 490 schools, Portaria 727 of 2017 for 358 schools, Portaria 1023 of 2018 for 179 schools, and Portaria 2116 of 2019 for 429 schools. The selection of which schools will join the EMTI follows proposals by each state through their SEEs, which follow the priority criteria set by each Portaria. Once selected, the SEEs receive about R\$2,000 per enrolled student. These funds support the SEEs with the cost of expansion and maintenance of the EMTI Program and are sometimes complemented by additional state funds. These resources have been allocated for eligible maintenance expenses and capital expenses, on average allocating 53 percent and 47 percent, respectively. Since 2022, capital expenditures increased slightly to 56 percent. The execution of these funds has been a key implementation hurdle; about R\$1.17 billion (approximately US\$260 million) were executed between 2018 and 2020, but a significant part of transferred resources has not been fully executed and has been left in SEE accounts (approximately R\$1 billion), mainly due to weak execution capacity in many states. This highlights the need to strengthen the fiduciary capacity of SEEs to execute the remaining funds.
- 9. The Operation originally included an optional mid-term evaluation of the EMTI program, but the technical design of the program led to methodological difficulties in its execution (e.g., non-random school selection, non-representative school samples). In this context, the MEC and the Bank agreed to instead undertake an impact evaluation with a non-experimental design that would allow a better assessment of the effectiveness of the EMTI. However, an extension of the Operation's current closing date is needed to allow MEC to conduct the proposed non-experimental evaluation and carry out a rigorous analysis of the processes, outputs, and outcomes by hiring a consulting firm to conduct the analysis and



- 10. The new administration recently launched the national Full-time School Program (*Programa Escola em Tempo Integral*, PETI), established by Law No. 14,640 of July 31, 2023. Its main objective is to foster the creation of full-time enrollment in all stages and modalities of basic education. Coordinated by SEB, the program aims to meet goal 6 of the National Education Plan 2014-2024 (Law No. 13,005/2014), which seeks to provide full-time schooling in at least 50 percent of public schools, in order to benefit at least 25 percent of students in basic education. The specific objectives of the PETI are to: (i) foster the provision of full-time schooling; (ii) elaborate, implement, monitor, and evaluate the PETI; (iii) promote the equalization of opportunities for access and permanence based on provision of full-time schools; (iv) improve the quality of public education to improve the learning outcomes and integral development of infants, children, and adolescents; and (v) strengthen the collaboration between federal and state governments, municipalities, and the Federal District for the fulfillment of Goal 6 of the National Education Plan. The Program will provide technical and financial assistance to foster 1 million enrollments in schooling that provides at least seven hours per day or 35 hours per week, considering pedagogical proposals aligned with the BNCC to promote integral education and prioritize schools that benefit students in situations of greater socioeconomic vulnerability.
- 11. The status of IRIs and DLIs for Results Area 2 is as follows:
 - i. IRI 3.2 (DLI 7) "Number of States that have their revised FTS Implementation Plans approved by MEC:" this indicator was achieved in 2018, and all states have had their FTS Implementation Plans approved by MEC.
 - ii. IRI 3.3 (DLI 8) "Evaluations and adjustment of the FTS program have been carried out:" this indicator has been partially achieved, meeting its 2019 target, which corresponds to DLR 1 "A Pre-evaluation is Satisfactorily completed." DLR 4 "A rigorous analysis of the processes, outputs and outcomes of the EMTI program is conducted and best practices to support its implementation are disseminated" is not expected to be achieved until after December 2023, as these activities depend on the consolidation of the institutional arrangement with FNDE and SGA.
 - iii. IRI 3.4 (DLI 9) "Percentage of agreed FTS key process targets achieved by States as included in their FTS Implementations Plans:" this indicator reached 82 percent in 2021, surpassing the end target of 75 percent.

Component 2. Technical Assistance to Implement the New Upper Secondary Education

- 12. While Terms of Reference for several key activities have been completed, only the contracts for PMU staff and consultants to support SEEs have been procured thus far, delaying the implementation of the activities planned under this Component. The reason for the delay in the implementation of this component is twofold. First, MEC suffered from recurrent changes in authorities (thus far, there have been six Ministers of Education and nine Secretaries of Basic Education since the beginning of the Operation), which led to subsequent turnaround in implementation staff and thus a difficulty in finalizing activities. Second, there was difficulty in aligning the Government's financial management procedures with the Bank's procurement guidelines. In particular, adapting the existing Information Technology (IT) payment system to the Operation's needs was much more complex than expected and took almost two years to be completed. Moreover, the lack of consolidation of the institutional arrangement with FNDE and SGA hampered the procurement processes of goods and consulting firms.
- 13. The status of this component's IRIs is as follows:
 - i. IRI 4.1 "Number of states that have promoted the participation of local communities in the design of pedagogical proposals in all FTSs:" 24 states have achieved 50 percent of planned activities promoting the participation of local communities on all FTSs, out of the target of 25 states.
 - ii. IRI 4.2 "Number of SEE with Implementation Plans to promote gender equality:" 15 SEEs currently have school-

- based interventions to promote gender equality in at least 40 percent of their schools, partially achieving the end target of 20.
- iii. IRI 4.3 "Percentage of female students enrolled in natural sciences and math itineraries:" no information has been systematized thus far to measure this indicator. This indicator was planned to be measured in the School Census 2022, but technical problems with the data collection hampered its dissemination. This indicator is expected be measured in the School Census 2023, for which results will be available in 2024.
- iv. IRI 4.4 "States where the average absolute gender gap of enrollment in formative itineraries is less than 5%, subject to available offerings:" No information has been systematized thus far to measure this indicator, in line with the issue related to the data collection of School Census 2022. This indicator is also expected to be measured in the School Census 2023, with results available in 2024.
- v. IRI 4.5 "Students benefiting from direct interventions to enhance learning:" This indicator has been partially achieved. MEC estimates that 800,000 students have benefited from the Operation thus far, compared to the end target of 2,400,000.
- 14. **Financial Management (FM)**. The Operation's Fiduciary Systems are currently rated Moderately Unsatisfactory, given that FM staffing/personnel and reporting arrangements are not adequately in place, jeopardizing the Bank's access to timely information. The analysis of eligible expenditures is still slow and the PMU's ability to document expenditures is considered critical, in view of the upcoming closing date. There were also uncertainties regarding the Program's prioritization by the current administration, which impacted FM. Regarding the 2024 budget, an amount of \$6.62 million has been allocated to the activities of Component 2, which is aligned with the proposed partial cancellation of this restructuring.
- 15. **Audits.** The audit report for the period ending on December 31, 2022, was received 63 days after the established deadline, but it was reviewed and accepted by the Bank.
- 16. **Procurement.** Procurement remains Moderately Unsatisfactory, per the Fiduciary rating in the latest ISR, given that only a few individual consultants have been hired. Operational aspects have also been slow, mainly due the technical undefinitions, high turnover among authorities, and uncertainty on the implementation arrangements. This delay in the procurement processes was mainly due to the lack of an institutional arrangement with FNDE and SGA. Given the delay in the implementation of procurement processes of goods and consulting firms until now, the restructuring is proposing to cancel some activities. Thus, only one process of acquisition of goods and one of consulting of firm will be conducted before the closing of the Operation. Capacity building will be provided to the FNDE and SGA to improve their capacity to carry out and streamline procurement processes.
- Safeguards. After an initial delay due to the deferral in the hiring of the Social and Environmental Management Specialist in the PMU, the pace of implementation of the Action Plan for Environmental and Social management has sped up and the Borrower has completed the recommended actions related to (a) elaboration of an Environmental and Social Management Guide, (b) the implementation of Environmental Screening Procedures with the application of the Screening Form, (c) the implementation of the Monitoring System for Socio-Environmental issues, (d) operationalization of the dedicated grievance redress mechanism, (e) carrying out a land inventory of the schools participating in the EMTI Program, (f) targeting investments in socially vulnerable school communities, (g) carrying out a diagnostic of the determining factors of gender inequalities in education, and (h) carrying out appropriate consultation to all interested parties on the New Curriculum for upper secondary. Considering the Technical Assistance nature of Component 2, the Environmental Assessment Category was rated C. However, two operational policies were triggered on a precautionary basis during Negotiations: OP 4.01 Environmental Assessment and OP 4.10 Indigenous Peoples. Compliance with operational policies has been continuously rated Moderately Satisfactory.



Rationale for Restructuring

- This proposed Level 2 restructuring responds to the Borrower's letter dated August 31, 2023, requesting a 18. restructuring of the Operation. This request arose out of the mission carried out in March 2023, and is based on ongoing dialogue throughout implementation and overall progress to date. Overall, this restructuring seeks to extend the Operation's closing date, update the results framework, adjust Component 2 and cancel a portion of its funds, update implementation arrangements and adapt the DLIs and activities to the priorities and needs generated by the suspension of the implementation schedule and public consultation to restructure the Upper Secondary Reform, as well as leverage the renewed commitment and political will to improve Brazilian education.
- First, this restructuring responds to the education community's request to extend the implementation schedule of the Upper Secondary Reform and reorient it following the 2022 Presidential election and the corresponding changes in administration of MEC. Proposed changes to adapt the Operation to this context include: (i) extension of the implementation schedule to give states more time to adapt their pedagogical strategies, school infrastructure, and governance to implement the revised reform, such as change the time allocation for the core subjects and the flexible part of the New Curriculum,² the revision of the curriculum of the flexible part, the provision of technical and vocational education (TVET), and the expansion of hybrid education; and (ii) strengthening of MEC financial and technical support to the states to tackle the bottlenecks in implementation, such as hybrid education to promote learning recovery strategies.
- 20. Second, the restructuring also seeks to address and overcome the implementation delays under Component 2, which were caused by the non-consolidation of the institutional arrangement to carry out procurement processes in coordination with FNDE and SGA, as well as the lack of budget allocation for the activities of the Operation. As such, this restructuring will cancel a portion of the funds allocated to Component 2 and update the action plan to define the roles and responsibilities of FNDE in conducting procurement of goods and the SGA in procurement of consulting firms.
- 21. Third, the restructuring will address the delay in the verification of eligible expenditures by strengthening the capacity of the PMU to conduct the verification of programs that depend on the information available at the state level, and with the revision of the action plan to add the roles and responsibilities of FNDE in the verification processes of eligible expenditures.
- 22. Fourth, it will adjust Component 2 and the Results Framework, including DLIs, to account for the delays experienced to date and help accelerate implementation, while providing needed clarifications and adjustments to definitions and protocols.
- 23. The proposed restructuring was approved by the Federal Government (the Guarantor) through recommendation (Recomendação) No. 43 dated December 6, 2023, and ratified by the General Attorney of the National Treasury (Procuradoria Geral da Fazenda Nacional - PGFN) on December 20, 2023. The amendment to the Loan Agreement will be effective retroactively as of January 2023, when the new administration of MEC took office.

II. DESCRIPTION OF PROPOSED CHANGES

24. The proposed restructuring would incorporate the following changes:

² The flexible part are the set of subjects that students will be able to choose from the NEM. The training itineraries can deepen the knowledge of an area of knowledge (Mathematics and its Technologies, Languages and its Technologies, Natural Sciences and its Technologies and Applied Human and Social Sciences) and technical and professional training.

- i. Extension of the closing date by 12 (twelve) months to account for the suspension of the implementation of the upper secondary reform until public consultations were completed in August 2023, and ensure completion of the key strategic activities related to the upper secondary reform.
- ii. Changes to the Project's Results Framework, including: (a) change in the targets and timelines of PDOIs, DLIs, and IRIs; (b) addition of three DLIs and seven IRIs; (c) adjustments to the definition and protocol of one DLI; and (c) elimination of three DLRs for Components 1 and 2.
- iii. Partial Cancellation of funds under Loan IBRD No. 8813-BR in the amount of US\$19,314,273 million.
- i۷. Changes to Component 2, including a reallocation of financing to strengthen existing activities critical for the implementation of the reform, mainly the expansion of hybrid education.
- A reallocation across Disbursement Categories to reflect the changes in DLIs. ٧.
- vi. Update of the disbursement estimates to reflect the changes to DLIs and the revised implementation timeline.
- vii. Correction of the Integrated Safeguards Datasheets (ISDS) to address an inconsistency in the version published for Appraisal vis-a-vis what was agreed during Negotiations.

Extension of the closing date

25. The proposed 12-month extension would respond to the delays caused by the recent change in MEC administration and the suspension of the reform implementation schedule while national public consultations were conducted, and would allow sufficient time to disburse the remaining loan funds. The additional implementation period would also allow MEC to finalize key activities needed to achieve the PDO in collaboration with the subnational governments. These include the implementation of the new curriculum in 40 percent of the 1st grade of upper secondary schools in 25 states; implementation of the new curriculum in 60 percent of the 1st grade of vulnerable upper secondary schools in 27 states; and implementation of a safe and effective reopening of upper-secondary schools, including the delivery of distance education as part of a hybrid model in at least 15 States. Furthermore, the extension of the closing date will allow the Operation to include the dissemination of the national public consultation, institutionalization of the revision of the Upper Secondary Education Reform, and elaboration and dissemination of guidelines for the redevelopment of curricula based on the restructuring of the Upper Secondary Education Reform.

Changes to the Results Framework

- 26. The end target dates for PDO Indicators 1, 2, and 5 will be changed to December 31, 2024, in line with the revised closing date. PDO Indicator 4 will remain unchanged given that it has already been achieved.
- 27. The restructuring will include changes in the names, targets, definitions and/or descriptions, and verification protocols of DLI and IRI indicators, and a change in the end target date for all indicators to reflect the closing date extension and changes proposed. The proposed changes and rationale are detailed in Annex 1, Results Framework and Monitoring.
- 28. Changes to DLI. Changes to DLIs will include revisions to the targets, definitions, and protocols of existing DLIs; addition of new DLIs; and dropping of others, in accordance with the latest strategies to address the public consultation of the reform and to simplify and accelerate disbursements. DLIs and DLRs are eliminated in cases where the original indicators no longer suit the Operation or are unattainable to support the accomplishment of the PDO. DLI names, descriptions, or verification protocols are revised in cases where changes in conditions require technical adjustments, but the overall technical core and role of these DLIs in support of the PDO remain critical. New DLIs are added in cases where new conditions or capacity needs have led to substantive new activities that new DLIs can help finance and motivate. Moreover, and given the existence of retained amounts from previous disbursement cycles (US\$40.5 million), new targets for DLR 6 will be added to specific DLIs to facilitate disbursement. Annex 3 presents the targets and results achieved under each DLI to date, including the new DLIs that will be added to the Operation through this restructuring.



- i. DLRs to be dropped (Total Value: US\$27.5 million):
 - a. DLR 4 of DLI 8 "A rigorous analysis of the processes, outputs and outcomes of the EMTI program is conducted and best practices to support its implementation are disseminated" (IRI 3.3, US\$15.0 million). Since achievement of DLR 4 depends on the implementation of Component 2, this DLR will be dropped given the challenges related to its implementation. It will, however, continue to be monitored under the new IRI 3.5.
 - b. DLR 5 of DLI 12 "Assessment matrixes of new ENEM are published" (IRI 1.15, US\$12.5 million). This DLR will be dropped given that it is not expected to be completed during the Operation's implementation period.
- ii. DLIs to be revised (Total Value: US\$12.9475 million):
 - a. DLI 13 "MEC implements measures to respond to COVID crisis": DLR 4 was partially achieved in 2022 (disbursed US\$10 million), when MEC delivered (i) health protocols for the safe reopening of schools and (ii) a panel to monitor the context and progress of each state, but the (iii) dissemination of strategies for the recovery of lost learning and for bringing students back to school has not been achieved yet, leaving a remaining balance of US\$5 million. The end target for (iii) will be changed to 2024 by converting it into the new DLR 6. DLR 5 was also partially achieved (disbursed US\$5 million) when MEC provided States with (i) technical and financial support to improve school connectivity. The second target of DLR 5 (ii) (equipment needed to offer distance and hybrid education (media centers and school kits) for US\$7.9475 million depends on the implementation of Component 2, putting the full achievement of the DLI at risk. Therefore, the second target of DLR 5 will be dropped and the remaining resources reallocated to a new DLI.

iii. DLIs to be added (Total Value: US\$34.9975 million):

- a. DLI 14 "MEC public consultation with students, teachers, and school managers on the NEM implementation process published" (US\$7.5 million): this new DLI will monitor citizen engagement in the revision of the reform based on the findings of the public consultation that engaged students, teachers, and school managers. This consultation will contribute to the revision of the reform by addressing the implementation challenges across the country.
- b. DLI 15 "Restructuring of the Upper Secondary Education Legal Framework published" (US\$10 million): According to Brazilian legislation, MEC is required to change Law 13415 to revise the reform. This new DLI will monitor the institutionalization of the new regulation on the time allocation to the main subjects and the flexible part, the revision of the curriculum of the flexible part, the provision of TVET, and the expansion of hybrid education.
- c. DLI 16 "Strengthening schools' connectivity through the provision of necessary equipment for hybrid education to promote learning recovery strategies" (US\$17.9475 million): DLR 6 would be scalable: (i) 20 states with media centers installed with equipment needed to deliver hybrid education (US\$7.4975 million); (ii) 1,000 vulnerable schools with school kits needed to deliver hybrid education (US\$10 million). In addition to the objective of revamping hybrid education to promote learning recovery strategies at the school level, the strengthening of school connectivity aims to help address key challenges raised during the public consultation. For example, the equipment for hybrid education will support activities to tackle the lack of guidance to implement the curriculum, the lack of teacher professional development, the inequality of school digital infrastructure, and the high demand to increase the coverage of technical and vocational education and full-time schools.



- 29. The following IRIs/DLIs will be added to the Results Framework. The proposed new DLIs will be fully consistent with the new programs, new Eligible Expenditure Programs, and updated TA activities.
 - i. IRI 1.17 (DLI 14): MEC public consultation with students, teachers, and school managers on the NEM implementation process published.
 - ii. IRI 1.18 (DLI 15): Restructuring of the Upper Secondary Education Legal Framework published.
 - iii. IRI 1.19 (DLI 16): Strengthening schools' connectivity through the provision of necessary equipment for hybrid education to promote learning recovery strategies.
 - iv. IRI 3.5: A rigorous analysis of the processes, outputs, and outcomes of the EMTI is conducted and best practices to support its implementation are disseminated.
 - v. IRI 4.6: Number of states with interventions to promote gender equality in at least 40 percent of their schools. This IRI aims to measure the capacity of MEC to provide technical assistance to the states on the implementation of gender equality interventions because of the gender gap related to the higher dropout of boys in upper secondary education.
 - vi. IRI 4.7: Number of states with interventions to promote racial equality in at least 40 percent of their schools. Similar to IRI 4.6, this IRI aims to measure the capacity of MEC to provide technical assistance to the states on the implementation of racial equality interventions because of the racial gap related to the lower performance and higher dropout of brown and black students.
 - vii. IRI 4.8: Publication and dissemination of guidelines for the tailored implementation of the Upper Secondary Education Reform in rural, afro-descendants (*Quilombolas*), indigenous, night shift, and youth and adult education schools. The new administration of MEC acknowledged that schools from specific and minorities groups needs a tailored support to reduce inequalities in the implementation of the upper secondary education reform. This IRI will monitor the publication and dissemination of tailored guidelines for each different type of school.

Partial Cancellation of funds under Loan IBRD No. 8813-BR

29. Based on a realistic assessment of the implementation capacity for activities under Component 2 and the lack of budget allocation for these activities, the Federal Government has requested a partial cancellation of US\$19,314,273 million, reducing the Component 2 amount from US\$29 million to US\$9,685,727 million (reduction of 33.3 percent). Given the already disbursed amount of US\$3.07 million, this would leave an amount of US\$6.62 million to be disbursed by December 31, 2024.

Changes in Activities under Component 2: Technical Assistance to Implement the New Upper Secondary Education.

30. Due to the partial cancelation of the funds of Component 2, the restructuring will update existing activities focused on supporting the redesign of the reform to reflect the public consultation and streamline implementation at the school level. These activities will include the expansion of hybrid education with the acquisition of more school kits, as well as rigorous analysis of the processes, outputs, and outcomes of the Reform.

Reallocation of Loan Proceeds

31. Loan resources will be reallocated across Categories to reflect the proposed changes in DLIs. The following table specifies: (a) each category of withdrawal of the proceeds of the Program Loan (including the DLIs, as applicable) ("Category") and the allocation of the amounts of the Program Loan to each Category; and (b) the categories of Eligible Expenditures that may be financed out of the proceeds of the Project Loan ("Category"), the allocations of the amounts of the Project Loan to each Category, and the percentage of expenditures to be financed for Eligible Expenditures in each

- 32. **Disbursement Estimates**. Estimates will be revised to reflect the changes in disbursement categories, actual disbursements, and the new implementation schedule.
- 29. **Safeguards**. The Operation's ISDS will be updated. Although the Program Document mentioned that OP 4.01 Environmental Assessment and OP 4.10 Indigenous Peoples were triggered on a precautionary basis, the disclosed Appraisal Stage ISDS did not reflect the decision agreed during Negotiation Stages to trigger OP 4.10 Indigenous Peoples, as it was disclosed prior to Negotiations. The ISDS will be updated to correct this inconsistency and reflect the new IRIs proposed under this restructuring. This restructuring adds three IRIs to the Results Framework that are expected to enhance the Operation's contribution to the social inclusion agenda: (i) IRI 1.17 "MEC public consultation with students, teachers, and school managers on the NEM implementation process published" is expected to enhance citizen engagement. (ii) IRI 4.6 "Number of states with interventions to promote gender equality in at least 40 percent of their schools" is expected to contribute to gender equity. (iii) IRI 4.7 "Number of states with interventions to promote racial equality in at least 40 percent of their schools" and IRI 4.8 "Publication and dissemination of guidelines for the tailored implementation of the Upper Secondary Education Reform in rural, afro-descendants (*Quilombolas*), indigenous, night shift, and youth and adult education schools" are expected to ensure that disadvantaged and vulnerable students get access to culturally adequate school education and a fair share of Operation benefits. Given that Component 2 only supports Type 1 Technical Assistance activities, this will not require the preparation of an Indigenous Peoples Planning Framework or an Indigenous Peoples Plan.

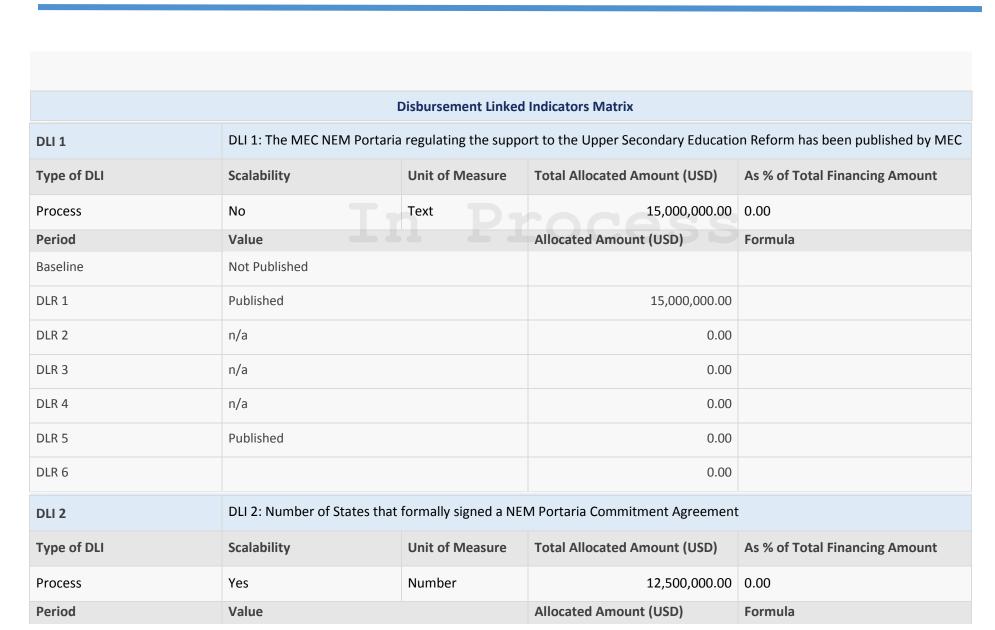

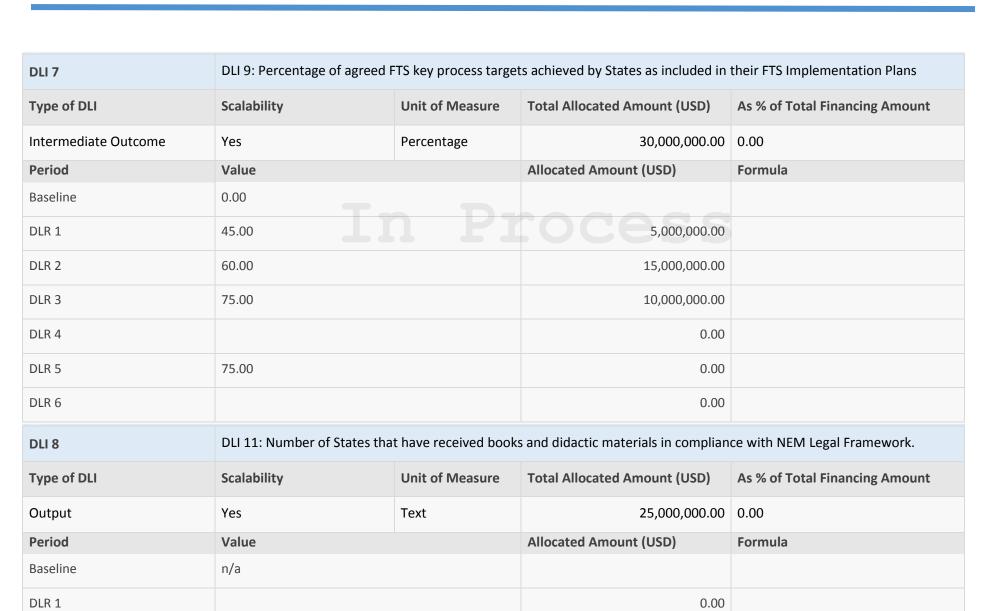
